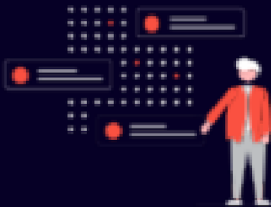
Our Mission

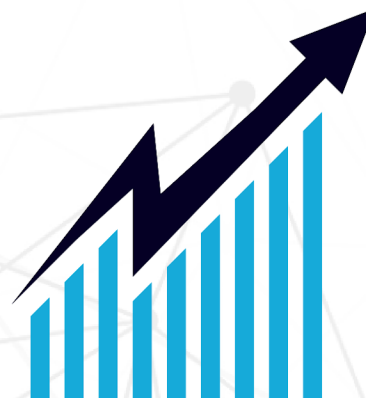

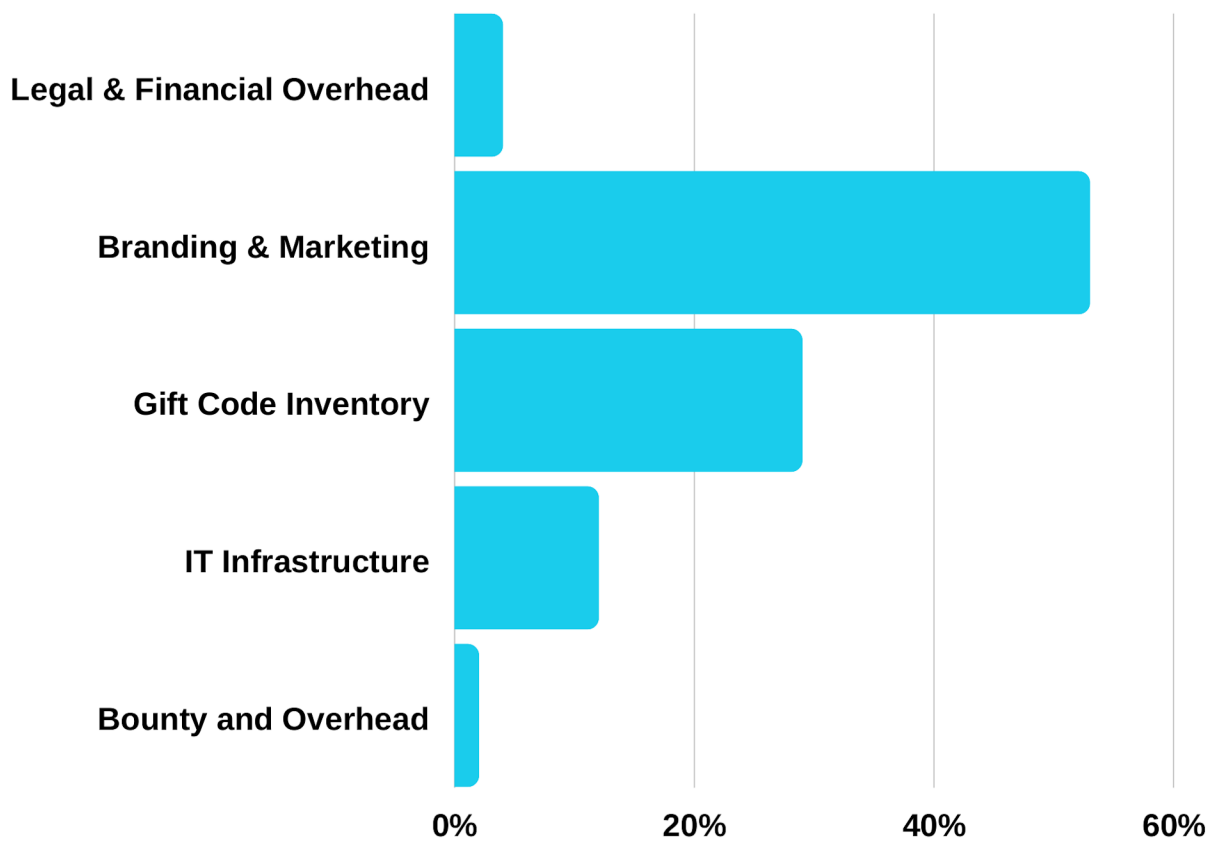

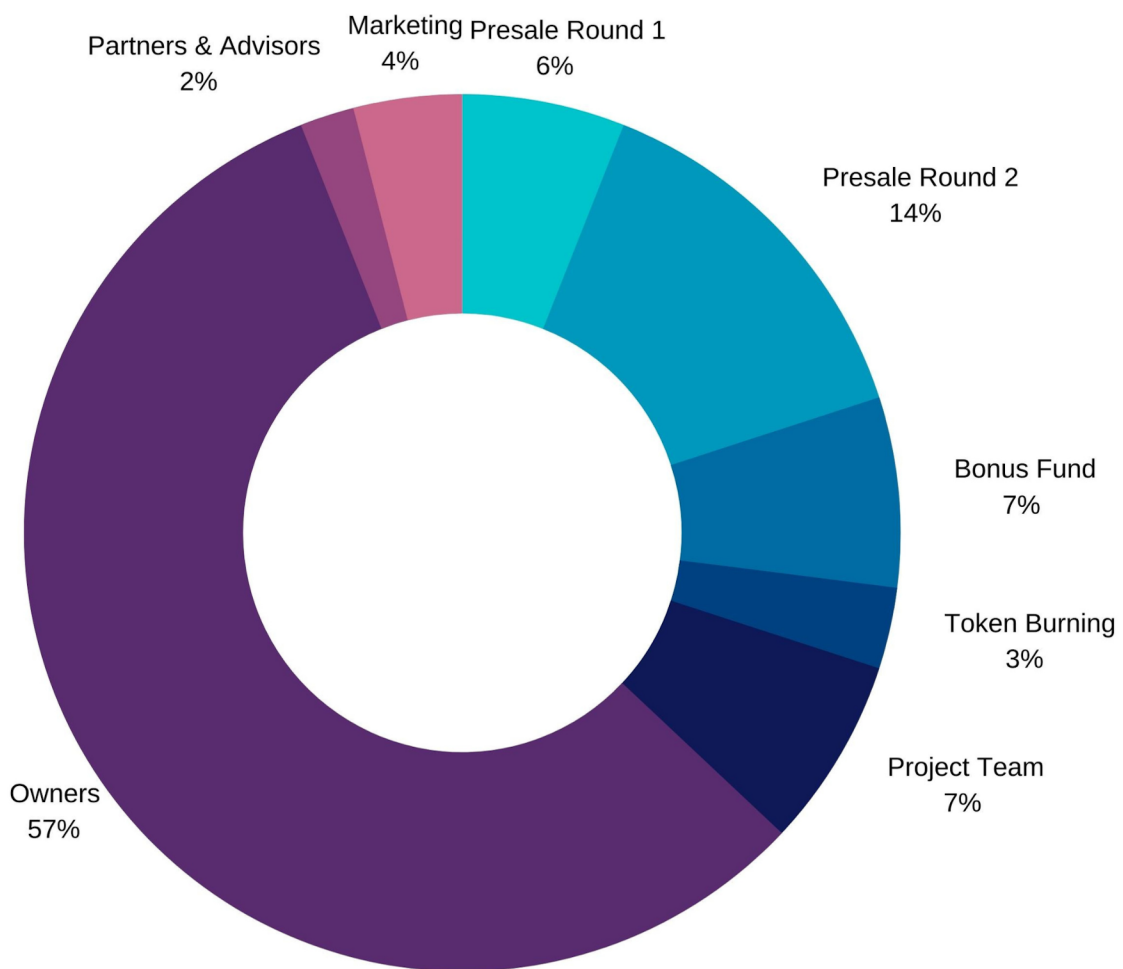
